# Street Parking Variance Request

1. There can be no open violations/compliance issues and all assessments must be current before a street parking variance request application will be reviewed.
2. Homeowner must completely fill out, sign and return this entire packet with photos of the inside of garage from the street with garage door(s) open, and photos of all vehicles parked in garage and on driveway.
  - a. Garage cannot be used for storage. The number of vehicles the garage is designed to hold, must be parked in the garage.
3. Parking Variance requests will be automatically denied if the garage is being use in any way that prevents the number of vehicles design to hold from being parked in the garage.
4. The Board will not grant permanent Street Parking Variances. **IF** a parking variance is granted, it will be on a temporary basis only.
5. Every request is reviewed on a case by case basis.
